

# 2025 U.S. Bank Student Scholarship Sweepstakes Official Rules

**NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**ARBITRATION NOTICE: BY ENTERING, YOU AGREE THAT DISPUTES BETWEEN YOU AND ANY PROMOTION ENTITY WILL BE RESOLVED BY BINDING, INDIVIDUAL ARBITRATION AND YOU WAIVE YOUR RIGHT TO PARTICIPATE IN A CLASS ACTION LAWSUIT OR CLASS-WIDE ARBITRATION. See Disputes/Arbitration provision.**

**ELIGIBILITY:** The 2025 U.S. Bank Student Scholarship Sweepstakes (“Promotion”) is only open and offered to entrants who, as of the entry date: are legal residents of the 50 United States and the District of Columbia (“U.S.”); are at least 17 years of age or older; are accepted or enrolled as an undergraduate student as of September 1, 2026, at an eligible, accredited two- or four-year U.S. brick-and-mortar or online college or university (undergraduate students must be enrolled for at least 6 credit hours per semester) or trade or vocational school (“Institution”); and meet the terms of these Official Rules (“Entrant”). **IMPORTANT NOTE:** Prior confirmed winners of a U.S. Bank Student Scholarship Sweepstakes are not eligible to enter or win a prize. Entrants who are under the legal age of majority in their jurisdiction of residence must obtain consent of their parent or legal guardian to enter and the latter must execute required documentation by and on behalf of their minor child.

Employees, officers, directors of U.S. Bank (“Sponsor”), GMR Marketing LLC (“Administrator”), Zogo, Inc., their respective subsidiaries and affiliated companies, agents, advertising/promotion agencies, individuals engaged in the development, production, or distribution of materials for, or implementation of the Promotion (collectively referred to herein as the “Promotion Entities”), and the immediate family members (spouse, siblings, children, including foster and step-relations who do not fall within the exception below) are not eligible to enter or win a prize. Void outside the U.S.; and where prohibited or restricted by law. Notwithstanding the foregoing, the following exception shall apply to eligibility; children, including foster and step-relations of Sponsor’s employees ARE eligible to enter the Promotion if the eligibility requirements outlined above are met.

*By entering the Promotion, Entrants fully and unconditionally agree to and accept these Official Rules, the information provided on [www.usbank.com/scholarship](http://www.usbank.com/scholarship) (the “Website”), and the decisions of the Sponsor and Administrator (and their authorized representatives) which are final and binding with respect to all matters pertaining to the Promotion and all elements thereof.*

**PROMOTION PERIODS:** The Promotion begins on or about 12 a.m. Central Time (CT) on February 1, 2025, and ends at 11:59 p.m. CT on October 30, 2025 (the “Promotion Period”). The Promotion Period will consist of two (2) entry periods (each an “Entry Period”). Entry Period 1 begins at 12:00:00 a.m. CT on February 1, 2025, and ends on 11:59:59 p.m. CT June 30, 2025. Entry Period 2 begins at 12:00:00 a.m. CT on July 1, 2025, and ends on 11:59:59 p.m. CT October 30, 2025. Non-winning entries will roll over from Entry Period 1 to Entry Period 2.

The clock on the Sponsor’s server shall be the official time keeping device for this Promotion. All time referenced in connection with the Promotion is Central Time. Entrants are solely responsible for determining the corresponding time zone in their respective jurisdictions; Promotion Entities disclaim all liability or responsibility relating thereto.

**REGISTRATION/HOW TO ENTER/MODULES:** In order to participate in the Promotion all Entrants must complete a

registration during the Promotion Period by visiting the Website and following the online directions for registration.

There are two ways to enter:

(1) Entrants register on the Website, access the links and complete in-full various offered learning activities (“Modules”) within the Zogo app (the “App”) during each Entry Period. Entrants must download the App and may select which Modules to complete within the App. Modules may vary in length and may be completed once. The stated minimum number of Modules are required for each drawing that takes place in the applicable Entry Period. In Entry Period 1; if an Entrant completes 25-49 modules, they are eligible for a Third Prize Scholarship Award of \$2500; if they complete 50-74 modules they are eligible for a Second Prize Scholarship Award of \$5000; if they complete 75-99 modules they are eligible for a First Prize Scholarship award of \$10,000. For the Entry Period 2; if an Entrant completes 25-49 modules, they are eligible for a Third Prize Scholarship Award of \$2500; if they complete 50-74 modules they are eligible for a Second Prize Scholarship Award of \$5000; if they completed between 75-99 modules they are eligible for a First Prize Scholarship Award of \$10,000; if they complete 100 or more modules, they will be eligible for the Grand Prize Scholarship Award of \$20,000. Entrants who complete the number of required Modules will earn one (1) entry into the applicable drawing (each is an “entry”), and up to seven (7) entries in total during the Promotion Period.

**OR**

(2) Once registered, eligible Entrants may enter without completing Modules by mailing a separate mail-in request for each Entry Period drawing to receive one (1) entry per drawing. To enter by mail: hand-print your full name, address (no PO boxes), contact phone, email address (used to register on the Website), and the eligible U.S. college or university at which you are or will be enrolled on a 3” x 5” card, and separately mail in a first-class sufficiently U.S. stamped envelope. **Each stamped envelope MUST also be clearly marked with the drawing into which the mail-in entry shall be entered (The “Grand Prize Scholarship Award Drawing,” “First Prize Scholarship Award Drawing,” “Second Prize Scholarship Award Drawing,” or “Third Prize Scholarship Award Drawing”).** Mail-in entries can be submitted to: “2025 U.S. Bank Student Scholarship Sweepstakes,” PO Box 511172, New Berlin, WI 53151. There will be two Entry Periods: Entry Period 1 will be open for entry from February 1, 2025, through June 30, 2025. Mail-in request must be postmarked by June 30, 2025, and received by July 7, 2025. Entry Period 2 will be open for entry from July 1, 2024, through October 30, 2025. Mail-in request must be post-marked by October 30, 2025, and received no later than November 5, 2025. Each separately marked and mailed eligible mail-in request received represents one (1) entry and will be assigned by Administrator into the respective drawing as indicated on the stamped envelope (Grand, First, Second, Third). *Entries without a drawing clearly indicated on the stamped envelope shall be considered incomplete, and invalid.* **Limit one (1) mail-in request per person/email per drawing, limit up to seven (7) mail-in requests during the Promotion Period.**

**Limit up to seven (7) entries per person/email regardless of entry method used during the Promotion Period.**

Incomplete, ineligible, or non-compliant entries are void. Entries become the property of Sponsor and will not be returned. Entrants may not enter through a sweepstakes club (or similar method whether or not paid), with multiple identities, devices, accounts, registrations, email addresses, IP addresses, and/or phone numbers, nor shall Entrants use any other device or artifice to enter or participate other than the App requirement to enter. Entries may only be submitted by a single registered user; group or commercial submissions are not permissible. Any suspected use of artifice, cheating, fraud, online clubs (or similar methods), exchange sites, robotic, automatic, macro, script, programmed or like methods as determined in Sponsor’s sole and absolute discretion, will void all such entries by such methods, and disqualify any Entrant suspected of using/benefitting from such methods. Without limiting the foregoing, Sponsor has the right to verify Entrants’ eligibility and compliance with these Official Rules and, on the basis of its investigation, to disqualify any entry/Entrant at any time during or after the Promotion Period, and will require immediate prize return in-full if applicable. Promotion Entities assume no responsibility for lost, late, incomplete, inaccurate, illegible, delayed, destroyed, damaged, not received, undelivered, postage due, or misdirected entries (in whole or in part). Entries must be complete, compliant, submitted via the method of entry communicated herein, and received by Sponsor within the time stated. Entries submitted via any other entry method will not be accepted.

An Entrant participating in the Sweepstakes via a mobile device consents to receiving communications – including but not limited to pre-recorded or artificial voice message calls, texts, and calls made by an automatic telephone dialing system – from Sponsor and its agents at that number. Message and data rates may apply. Entrant should consult his/her wireless

service provider regarding its pricing plans. Participation may not be available on all mobile devices. Consent is not a condition of purchase.

**RANDOM DRAWINGS/ODDS/NOTIFICATION:** Administrator will conduct a separate random drawing for each Entry Period from among all eligible entries received during the Promotion Period. On or around July 8, 2025, Administrator will randomly select three (3) potential winners, one Third Prize Scholarship Award winner, one Second Prize Scholarship Award winner and one First Prize Scholarship Award winner, from among all eligible entries received during Entry Period 1. Nonwinning eligible entries will automatically rollover into the Entry Period 2 drawing. Additionally, modules that registrants complete during entry period 1 will count toward their entry period 2 completion number.

On or about November 7, 2025, Administrator will randomly select four (4) potential winners, one Third Prize Scholarship Award winner, one Second Prize Scholarship Award winner, one First Prize Scholarship Award winner, and one Grand Prize Scholarship Award winner from among all eligible entries received during Entry Period 2 and all non-winning eligible entries from Entry Period 1. All random drawings will be conducted under the supervision of Sponsor, whose decisions are final. Odds of winning a prize depend on the number of eligible entries received during the Entry Periods.

Odds of winning depend on the number of eligible entries received for each drawing during the Promotion Period. Potential winners will be notified by phone and/or email (in Sponsor's sole discretion) on or about seven (7) business days after the drawing. The potential winners will have forty-eight (48) hours from the time of the first notification to respond or the winner will automatically forfeit the prize and an alternate winner may be randomly selected as the Prize winner, time and circumstances permitting.

Potential winners (or if a minor their parent/legal guardian) will be required to complete, sign, and return an Affidavit of Eligibility, Liability and, where lawful, Publicity Release within seven calendar (7) days of notification, or else prize will be forfeited and an alternate potential winner selected for the applicable prize/level from remaining eligible entries received for the applicable drawing. Additional documents may be required respecting Prize award as determined by Sponsor and/or Institution as applicable.

**PRIZES/APPROXIMATE RETAIL VALUE ("ARV"):** Assuming sufficient eligible entries are received, the following prizes ("Scholarship Award(s)") are available to be awarded, subject to verification and compliance of potential winners:

- Two (2) Third Prize Scholarship Awards (one awarded each Entry Period): \$2500 Scholarship Award: Register + completion of at least 25 modules or 1 mail-in request to be eligible
- Two (2) Second Prize Scholarship Awards (one awarded each Entry Period): \$5000 Scholarship Award: Register + completion of at least 50 Modules or 1 mail-in request to be eligible
- Two (2) First Prize Scholarship Awards (one awarded each Entry Period): \$10,000 Scholarship Award: Register + completion of at least 75 Modules or 1 mail-in request to be eligible
- One (1) Grand Prize Scholarship Award: \$20,000 Scholarship Award: Register + completion of at least 100 Modules or 1 mail-in request to be eligible

Total Approximate Retail Value of all Scholarship Award Prizes awarded is up to \$55,000.

Scholarship Award will be paid in U.S. dollars, within one year of the prize being accepted by the winner, upon receipt of all completed documentation from the winner necessary to process the payment and confirm eligibility and will be paid directly to the Institution at which the eligible winner is accepted and enrolled. Scholarship Award must be used towards the winner's academic financial support and qualifying expenses as determined by Sponsor and Institution (e.g., tuition, books and other educational materials and fees), and excludes meals, room and board, and similar living expenses. The Scholarship Award payment will be made as a single one-time payment and will be applied to the eligible winner's student account at the Institution and will be subject to the limitations of the Institution's payment requirements. All Scholarship Award payments will only be applied if the winners remain enrolled at the time the Scholarship Award is to be paid and in good standing at the Institution or else the Scholarship Award will be forfeited. Scholarship Award payments will be made within a three-month timeframe and/or at an agreed upon time between the Sponsor and winner.

If any Scholarship Award recipient is officially subject to suspension or expulsion from their Institution for any reason, brings public scandal or disrepute onto Sponsor, becomes ineligible (by for example taking less than 6 credit hours per

semester), withdraws without proof of transfer to alternate accredited Institution, or subsequently becomes otherwise ineligible for the Scholarship Award for any other reason, any portion of their Scholarship Award that is remaining, unused, unclaimed, un-awarded or unearned will be immediately subject to forfeiture by such winner, and such remaining Scholarship Award amount will be immediately due and returnable to the Sponsor. Provided a Scholarship Award recipient remains eligible (and compliant with these Rules, Affidavit and subsequent Scholarship Award related documentation), it is each winner's sole responsibility to arrange for and execute all documentation required by Sponsor and/or the Institution(s) for any remaining Scholarship Award amount of their Scholarship Award, for example, to be applied to future tuition costs and/or transferred to their transfer Institution, or else remaining Scholarship Award amount will be forfeited and immediately due and returnable to the Sponsor. Scholarship Awards, their use, details, limitations and restrictions and any other elements relating thereto are subject to terms and conditions established by each Institution, which vary. Promotion Entities disclaim all liability and responsibility for any Scholarship Awards once awarded.

**Limit one (1) Grand, First, Second, or Third Scholarship Award prize per person. Prior confirmed winners of a U.S. Bank Student Scholarship Sweepstakes are not eligible to enter or win a prize and will be disqualified.** All prizes are subject to compliance, verification of eligibility and receipt of all documentation from the potential winner necessary to process payment. All details and other restrictions of prizes not specified in these Official Rules will be determined by Sponsor (and Institution, as applicable) in their absolute discretion.
